
### **Greetings Friends**,

Good News for 1:1 Reading Mentoring: M4RA's parent organization, the Ohio Coalition for the Education of Children with Disabilities (OCECD) recently learned that they will receive a 5 year federal grant starting in October 2015. This grant will allow M4RA to work with youth who are incarcerated in juvenile detention centers, juvenile prison schools as well as continuing to provide professional development opportunities for Ohio schools/organizations that want to provide 1:1 reading mentoring for their children and youth.

"In the M4RA Spotlight": Mentor A Pirate at Wheelersburg Elementary: Tina has begun this year with 45 students and about 50 Mentors. She has shared photos, and her recent activities to recruit Mentors. We need to compare the fluency gains with Cold Reads at the same level from beginning your mentoring program until the student leaves or the end of the year. Be sure to use Non-fiction both times OR Fiction both times at the same Comprehension Level.
